The Supplier need take no action against the Customer before proceeding to enforce the terms of this Guarantee.

The undersigned further agrees that the provisions hereof shall inure to the benefit of the successors and assigns of the supplier to the same extent as if they had been named herein as parties entitled to the benefit hereof and that the provisions hereof shall apply to and bind the heirs, administrators, successors and assigns of the undersigned.
